Manuel G. Avilés-Santiago is Assistant Professor in Communication and Culture at Arizona State University. He obtained his Ph.D. in Media Studies in the department of Radio-TV-Film at the University of Texas-Austin. His manuscript, titled *Puerto Rican Soldiers and Second-Class Citizenship: Representations in Media* (2014, Palgrave Macmillan) examines the cultural history of the imaginary of the Puerto Rican soldier, from representations in traditional media to self-representations in digital/social media. His research interests are located within the areas of Latino/a and Spanish Caribbean Media Studies. Born in Mayaguez and raised in Aguada, Puerto Rico, Aviles-Santiago holds a Bachelor Degree in Communications and a Master in Research in Communications from the University of Puerto Rico at Rio Piedras.

Sheryl C. Gifford is a senior instructor in the Department of English at Florida Atlantic University. Her research interests include gender studies, paradigms of creativity, psychoanalytic criticism, and comparative and interdisciplinary approaches to African American and Anglophone Caribbean literatures. She is currently completing a manuscript that examines the contemporary Anglophone Caribbean male writer's development of literary authority from a psychoanalytic critical perspective.

Sheri-Marie Harrison is Associate Professor of English at the University of Missouri, where she teaches courses in Caribbean and African Diaspora literary and cultural studies. Her work is published in *Anthurium*, *Modern Fiction Studies*, *Contemporaries*, and *The Los Angeles Review of Books*. Her first book *Jamaica's Difficult Subjects: Negotiating Sovereignty in Anglophone Caribbean Literature and Criticism* was published by The Ohio State University Press in fall 2014.

Karima K. Jeffrey specializes in African-American Literature, Multi-Ethnic American Literature, Caribbean Literature and Postcolonial Studies. She is especially interested in Interdisciplinary Studies, incorporating film, music, visual arts, and other forms of media and technology into her research. Notable works by her are: "Mother of a New World? Stereotypical Representations of Black Women in Three Postapocalyptic Films" (*Journal of Feminist Scholarship*, 2014); "George Lamming's *In the Castle of my Skin*: A Littoral Figure Discovers Self-Identity and Authorial Language" (*Journal of Literature and Art Studies*, 2012); "Littoralia or the Littoral as Trope: Developing a Paradigm of Post-coloniality" (*C.L.R. James Journal*, 2010); and a biography on Langston Hughes in *Icons of African American Literature* (2011). Dr. Jeffrey is the recipient of Faculty Development Awards from the Historically Black Colleges/Universities-Faculty Development Network (2012), the University of Richmond Tocqueville Seminars (2011-2012), UNCF/Mellon Programs (2010-2012), Hampton

University (2009), and Hope College (2006). Other honorary distinctions include invitations to the National Humanities Center (2011), the University of Richmond Tocqueville Seminar on Transatlantic Studies (2011), and a New York University Faculty Resource Network Summer Seminar on Classical Studies and Postcolonial Literature (2013). She coordinated a Hampton University UNCF/Mellon Teaching and Learning Institute, entitled "Extending a Legacy of International Presence and Outreach at HBCUs-Social Justice and Educational Policy for the Twenty-First Century" (2011), and in 2014, she moderated a panel and was a presenter at New York University's Faculty Resource Network's annual symposium, "The Global Imperative for Higher Education." She is an Associate Professor of English at Hampton University.

Kelly Baker Josephs is Associate Professor of English at York College. She is editor of *sx salon: a small axe literary platform* and manages *The Caribbean Commons*.

Alison Klein is a full-time lecturer in the English Department at the University of Massachusetts, Dartmouth. She earned her Ph.D. in English Literature from the CUNY Graduate Center, specializing in postcolonial literature. Her dissertation, *The Ties that Bind: Gender, Race and Empire in Caribbean Indenture Narratives*, traces the ways that oppressive gender roles and racial tensions in the Caribbean today developed out of the British imperial system of indentured labor. Her work has been published in *South Asian Review*, *The Journal of Commonwealth Literatures*, and *Exit 9*.

Sobeira Latorre is Associate Professor of Spanish at Southern Connecticut State University. Her research focuses on the interrelations between the Spanish-speaking Caribbean and the Latin@/Caribbean diaspora with an emphasis on Afro-Latinas and women's writing.

Kara Rabbitt currently serves as Dean of the College of Humanities and Social Sciences at the William Paterson University of New Jersey. Prior to entering administration, Dr. Rabbitt served as founding director and faculty member of William Paterson University's French and Francophone Studies program. She earned her undergraduate degree at the University of California at Santa Cruz, with majors in Language Studies and Comparative Literature, and her masters and doctorate in Romance Studies, French Literature and Linguistics, from Cornell University. Specializing in Francophone Caribbean literature, with related expertise in nineteenth-century French poetry, she has published journal articles, book chapters, and webpages on these areas of research, as well as presenting in national and international conferences.

Guillermo Rebollo-Gil (San Juan, 1979) is a research professor at the School of Social and Human Sciences in Universidad del Este (Carolina, PR). His poems have appeared in *Fence*, *The Caribbean Writer*, *Counterpunch*, and *Mandorla*. His scholarly work has been published in *American Behavioral Scientist*, *Ethnic & Racial Studies*, *Sargasso*, *University of Puerto Rico Law Review* and *The Postcolonialist*, among other academic journals. He is the author of several poetry and essay collections, among them *Fire Island (The New Heave Ho)*, 2014).

Andrea Shaw Nevins is Chair of the Department of History and Political Science and Professor of English at Nova Southeastern University in Ft. Lauderdale. She is a creative writer and a scholar of Caribbean and African Diaspora studies and author of *The Embodiment of Disobedience: Fat Black Women's Unruly Political Bodies*. Her forthcoming book, tentatively titled “*Working Juju: Representations of the Caribbean Fantastic*.” is under contract from the University of Georgia Press for publication in 2017. Her creative and scholarly writing has been published in numerous journals, including *Small Axe*, *World Literature Today*, *MaComère*, *The Caribbean Writer*, *Crab Orchard Review*, *Feminist Media Studies*, and *Social Semiotics*. She graduated from the University of Miami with a Ph.D. in English and from Florida International University with an M.F.A in Creative Writing. She is associate managing editor of *sx salon: A Small Axe Literary Platform*, and on the editorial board of *Anthurium: A Caribbean Studies Journal*.

Josune Urbistondo holds a Ph.D. in English Literature from the University of Miami where she is currently a lecturer in the composition program. Along with teaching writing and literature at UM, she also teaches political science writing at Florida International University. Her research interests include Caribbean and Latino literature, gender studies, and visual rhetoric.
